Background & Tax Deductibility

Give2Asia is recognized as a tax-exempt public charity in the United States (ID# 94-3373670).

According to the IRS as of the drafting of this form, **"In general, contributions to charitable organizations may be deducted up to 50 percent of adjusted gross income."** Give2Asia does not offer tax advice and recommends you speak with a financial advisor to understand how best to structure your gift for maximum tax benefit.
